- All research funds approved for faculty research projects must be utilized within two years of allocation of funds. Afterwards, the funds will be considered lapsed, and no extension will be given for project fund utilization.
- At least, one external and one internal review must be carried out for the Ph.D proposals. The proposal must only be submitted before the ASRB for approval after addressing the comments, if any. Further, the PGRC must ensure that the comments of the reviewers have been addressed appropriately.
- The Board approved the following declaration form that is to be submitted by the applicant at the time he/she applies for the research incentive.
