Subject: **DLSEI - II, Launch of Online Learner Registration Portal**

Dear Sir/Madam,

Reference to letter No. 1-11/HEC/IT/PMNLS/2021/25 dated July 29, 2021, regarding the launch of Digital Learning & Skills Enrichment Initiative (DLSEI - II), it has been observed that student registration process has been extremely low due to various challenges like registration and fee deposit by the learners manually to the focal persons and where especially no focal persons are nominated, or creation of bank account is pending at the HEIs.

Considering this, the HEC advisory committee has approved the following modifications to the DLSEI-II Program in order to make the application process seamless for the learners and maximize registrations:

1. Development of an online portal which will be operational tentatively by 1st January 2022 where all learners will be able to apply online and pay their fee directly to the HEC account; and after passing 3 courses, 100% fee will be reimbursed to learners (*meanwhile, the current manual process of registration and fee collection at the end of focal persons will continue till the portal is live*).
2. University quota has been removed and licenses are now open for all public sector universities to avail on first come, first served basis.
3. Extend the opportunity free of cost to EHSAAS awardees (5%) and differently abled students (2%), after due verification from EHSAAS database, on first come, first served basis.
4. Restriction of graduation date has been removed for Alumni.
5. In case the HEI has not yet nominated a focal person, the same may be nominated on priority.

It is worth mentioning here, that the licenses have a one-year expiry date which have been activated from August 2021. In this regards, marketing material/ brochures are being enclosed with this letter for wide circulation and display at your university. You are requested to direct your focal person to raise awareness of the program updates and increase registrations through (but not limited to) the following means:

- Social Media Platforms including, Facebook, Twitter, WhatsApp groups, LinkedIn, etc.
- University Website and through Learning Management System (LMS)
- Email/ SMS to all university students/ faculty regarding the program updates
- Seminars/ Webinars/ Road Shows in the university and various campuses
