

Subject: **NO SMOKING / NO DRUG POLICY**

You are requested to submit the compliance report through email by 23<sup>rd</sup> December 2021 on the decisions already notified at Sr. 1 & 4 of this office letter No. Univ/Reg/PS/94 dated 08.03.2021 (copy attached).

It is reiterated that:

1. The Code of Honour for students given in the prospectus should be strictly observed. "No smoking / No drugs" signboards will be fixed at all appropriate locations by the Departments, if not already fixed, by 23<sup>rd</sup> December 2021.
2. The Project Director (B&W) will arrange fixation of "No smoking / No drugs" signboards at common places, if not already fixed, by 23<sup>rd</sup> December 2021.
3. At the start of a lecture, the teachers must remind students about strict adherence to no smoking and no drug policy.
4. The R.O. Office, Senior Warden Office, Security Office and the Proctorial Board will work in a tight coordination for the strict implementation of SOPs, especially in the use of narcotics and smoking.
5. Entry of all outsiders coming to the university playgrounds for sports activities, with due permission, shall be monitored by the Sport Office and Security Office.



Subject: **DECISIONS MADE IN THE MEETING OF DEANS, CHAIRPERSONS AND  
CAMPUS COORDINATORS HELD ON 3<sup>rd</sup> MARCH 2021**

A meeting of Deans, Chairpersons and Campus Coordinators was held on 3<sup>rd</sup> March 2021 under the convenorship of Vice-Chancellor to consider the recommendations of the Anti-Narcotics Task Force (ANTF). In the light of deliberations on the recommendations of the ANTF, following short-term and immediate decisions are notified for compliance by all concerned:

1. The Code of Honour for students given in the prospectus should be strictly observed. "No smoking / No drugs" signboards will be fixed at all appropriate locations by the Departments. The Project Director (B&W) will arrange fixation of such signboards at common places.
2. The contractors concerned will fix "No smoking / No drugs" signboards at their cafeterias/canteens/shops and will be responsible to ensure smoke/drug free environment in their premises.
3. The university will arrange awareness seminars and lectures with the help of Anti-Narcotics Force (ANF), Government of Pakistan.
4. At the start of a lecture, the teachers must remind students about strict adherence to no smoking and no drug policy.
5. Backside gates (Churkharies) at Main campus will be opened for limited notified time only.
6. Beggars and strangers are not allowed to enter the university premises from any entry point. The residents would immediately inform the Security Office (042-99029400) if some beggar comes to any home. Security Office will be held responsible if beggars or strangers are found on campus.
7. The R.O. Office, Senior Warden Office, Security Office and the Proctorial Board will work in a tight coordination for the strict implementation of SOPs, especially in the use of narcotics and smoking.
8. Entry of all outsiders coming to the university playgrounds for sports activities, with due permission, shall be monitored by the Sport Office and Security Office.
9. Underage driving (motorbikes, cars, rikshaws, etc.) is banned on campus and anyone found involved will be fined. His / her vehicle will be confiscated until fine is paid.
10. The data form of the residents of servant quarters at Main Campus, duly verified by the Police, will be provided by the House Allottee (Teacher/Officer) till March 31, 2021.
